### **CLAUSE 1**

#### **CO-OPERATION**

## CLAUSE 2 SCOPE OF THE MOU

## CLAUSE 3 INTELLECTUAL PROPERTY

3.1 Nothing contained in this MOU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

#### **CLAUSE 4 VALIDITY**

- 4.1 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period **Ecomoceana Technologies Pvt Ltd**, the Second Party, as the case may be, will take effective steps for implementation of this MOU. - 4.2 Both Parties may **terminate this MOU** upon **30 calendar days'** notice in writing. In the event of Termination, both parties have to discharge their obligations.

#### **CLAUSE 5**

#### **RELATIONSHIP BETWEEN THE PARTIES**

It is expressly agreed that **Sant Baba Bhag Singh University**, **Distt. Jalandhar and Ecomoceana Technologies Pvt Ltd**, **Mohali** are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.

Any divergence or difference derived from the interpretation or application of the MoU shall be resolved by arbitration between the parties as per the Arbitration Act, 1996. The place of the arbitration shall be at District Head Quarters of the First Party.
