CLAUSE 1

- 1.1 Both Parties are united by common interest and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institution and its related wings. CLAUSE 2

SCOPE OF THE MoU

CLAUSE 3
